Public policy on food situation

- Constitution, Art.43, 21 "right to food"
- Sessional Paper No. 1 of 2012 on the National Food and Nutrition Security Policy
- Other policies:
 - Motion of 2015 by County Assembly for the Executive to establish food security surveillance system
 - Nairobi City County Disaster and Emergency Management Act

- Response plans the "early action" EA









MoU on food security surveillance (3)

Roles

- NCC
 - Food security surveillance
 - Institutionalization, escalation to whole county
 - Assess / address ailments from food insecurity
 - Linkage with national government
- UEWEA Consortium
 - Training NCC teams
 - Financing
 - Build capacity of 7 subcounties on UEW & EA

- 3. Briefing of enumerators
- Collection and submission of data household & markets
 - 7-day mission
- 5. Analysis of data & generation of report
- 6. Dissemination of report
- 7. Response

Early action (2)

- A responsibility of the Disaster and Emergency Management Council
 - established under NCC DEM Act, No. 6 of 2015
- Through Partners;
 - Food supplements supplied in Korogocho after February 2017 surveillance
 - Cash transfer done to residents of Kibera and Korogocho after the November 2017 surveillance.







Action Plan

- UEWEA initiative was incorporated in the County Integrated Development Plan, 2018-2022 and in workplan and budgets as routine activity.
- Continuation of capacity building for UEWEA service.
 - UEWEA dashboard and enabled phones are being donated to NCC by Partners.
 - Continuation of partnerships in the service.
- Continuation of food security surveillance and response to food insecurity emergencies.
