
Each County Government will be responsible to cover only the Local Expenses Fee and Return airfare for its delegates.

Local living expenses Fee is reduced to \$5,450 USD and includes: full board, accommodation, study tours and field visits, medical insurance and airport transfers in Israel.


On-site guidance and mentoring programmes will be offered to each County Government through a separate implementation agreement.


